The Meeting was called to order by Mayor Rhoads.

The invocation was given by Alderman Harmon.

Item #1-Public Hearing on an application filed by Max Food & Beverage, LLC (Mississippi Legends Grill) requesting a Special Use Permit to allow the parcel of land located at 5649 Lakeland Drive, Suites C & D, to be designated a Qualified Resort Area allowing for the sale of alcoholic beverages

The required application and notices having been filed and given (copies attached), the Mayor opened a public hearing on the above matter and asked for those desiring to speak for or against the Application to speak. Amy Lovell spoke in favor of the application being granted. No one spoke against the application being granted. The Mayor closed the public hearing.

BE IT REMEMBERED that the Mayor and Board of Aldermen of the City of Flowood met at their regular meeting place on January 19, 2021 at 6:30 P.M.

The following members were present: Mayor Gary Rhoads, Alderman Deron Harmon, Alderman Kathy Smith, Alderman Don Flynt, Alderman Dusty Rhoads, Alderman Kirk McDaniel and City Clerk Josh Carlisle.

OTHERS PRESENT: Rusty Fortenberry, Shannon Spence, Garry Miller, Ricky McMillian, Paul Forster, Mike Prestage, Nathan Harvell and Jeffrey Welborn.

The Meeting was called to order by Mayor Rhoads.

The invocation was given by Alderman Smith.

Item #1 – Public Hearing on an application filed by KTS Real Estate, LLC for rezoning 48 acres from C-1 and C-2 to C-3, said property being identified as tax parcel #E10D-2. The proposed use of the property is for office space, a training facility, outside storage of vehicles, a company owned body shop and a shop bay – Mike Prestage

The required application and notices having been filed and given, the Mayor opened the public hearing on the above matter and Mike Prestage presented the application. The Mayor asked for those desiring to speak for or against the Application to speak. Johnny Dewitt was present on behalf of KTS Real Estate, LLC and spoke in favor of the application being granted. No one was present to speak against the application being granted. All documents for consideration were presented and attached to the minutes. The Mayor closed the public hearing.

A motion was made by Alderman Smith to grant the application filed by KTS Real Estate, LLC to rezone the land currently zoned C-1 and C-2 (tax parcel #E10D-2) to a C-3 zone district classification. This motion was seconded by Alderman Harmon and received unanimous approval from all Board Members present. There was no request that the City Clerk read the Ordinance granting the Rezoning. Said Ordinance is attached hereto and incorporated herein.

Item #2 - Public Hearing pursuant to MCA section 21-19-11 with regard to a determination of a public nuisance at 120 Eastview Drive (Parcel/PPIN #J12A000002 00110) — Mike Prestage and Shannon Spence

A public hearing was held regarding the condition of the property located at 120 Eastview Drive (Parcel/PPIN #J12A000002 00110), whereupon Mayor Rhoads opened the hearing. The City Attorney provided a copy of the Notice of hearing pursuant to MCA 21-19-11 (1972 As Amended) and it was confirmed that all pre-requisites to the public hearing had been met. The Notice of hearing is appended hereto along with pictures from Flowood Code Enforcement Officer Shannon Spence showing the condition of the property. Mike Prestage and Shannon Spence described the condition of the property and stated that the mobile home burned the previous weekend. A Flowood Fire Department memorandum dated January 13, 2021 was attached to the minutes. The property owner and property tenant, as well as any other person having an interest in and to the subject property and/or other person desiring to make any public comment or to present any additional matters related to the subject of the public hearing were requested to come forward and address the Board. James Eady and Christa Smith, the children of the property owner, appeared on behalf of their father. Mr. Eady stated that the tenant had been evicted by Justice Court Judge Richard Redfern during October 2020 but had refused to leave. Mr. Eady also stated that the mobile home was uninhabitable and that they wanted the property cleaned. The property tenant did not appear. Thereupon, having considered all attendant facts and circumstances related to the subject matter of the public hearing and the subject property as well as incorporating all documents and things presented hereto, and finding that the subject property in its current condition constitutes a menace to the public health and safety of the community, Alderman Flynt made a motion to adopt a Resolution (attached hereto) directing the clean-up of the property; directing the filing of a Lis Pendens notice regarding the action of the Board relative thereto; and, thereafter directing that all assessment of penalties and costs as provided by statute be presented to the Board. The motion was seconded by Alderman McDaniel and received unanimous consent from all Board members present.
