**BE IT REMEMBERED** that the Mayor and Board of Aldermen of the City of Flowood met at their regular meeting place on October 16, 2023, at 6:30 P.M.

The Meeting was called to order by Mayor Rhoads.

The invocation was given Alderman Robbins.

Item #1 – Public hearing on an ordinance imposing a temporary moratorium on the issuance of privilege licenses or building permits for car wash facilities within the city limits of the City of Flowood, Mississippi.

This matter being set for hearing and public notice given, the Mayor opened the public hearing and asked for those desiring to speak for or against the proposed ordinance to speak. No one spoke on the matter. The Mayor closed the public hearing.
